

2021 4-H Presentations

As in 2020, our 2021 County, District, and State Activity Days will be virtual. This will consist of recording your presentation and submitting it online to the judged. The county videos will be judged and you will receive feedback about your video.

The top 2 placing entries from each category and age group will move on to the district competition. These presenters will have the option to re-record their video using the suggestions made by the county judges or may submit the same video for judging on the district level. The videos will be judged and feedback as well as placings will be sent to the presenters.

Again, the top 2 placings from each category and age group from district will move on to state. Presenters will again be given the choice or re-recording their video, or using the same video used for district.

Important Dates:

- County Videos Due – April 20 at 5:00 PM
- District Videos Due – May 24 at 8:00 AM
- State Videos Due – TBD (We expect early to mid July)

Special Rules for Virtual Competition:

- **All participants MUST be registered in 4-H Online before entering**
- Videos of youth presenting their presentations
 - Videos must be single cut - do not do several recordings and splice them together. **SINGLE CUT ONLY** - just as if youth are presenting live.
- Must see youth doing their presentations.
 - You cannot use Zoom and do a screen share, we must be able to see you also.
- Teams can be together to record their presentations as long as they are following the Governor's Orders and the CDC recommendations at the time of the recording.

- Teams - use zoom or something similar to record you both on the screen at the same time. (Use co-host to share the roles).
- Videos cannot be bigger than 10GB - smaller is better
- Videos must be .mp4 file format or .mov as these are universal and we should be able to open them easily. We do not want links to a YouTube channel or anything else. Please upload the video directly in the google registration.
- No tasting unless it's part of the outdoor cookery and or national competition guidelines
- Utilize materials that you could bring to a traditional face to face presentation.
- You will have the option to upload other files in addition to your video (ex: PowerPoint, photo of presentation poster, etc)

Outdoor Cookery

- Will be held face-to-face using the same rules and regulations outlined on the state website.
- North Central District competition will be June 18 in Stokes County.
